## **GUIDELINES FOR AUTHORS: CLINICAL**

**INTERNATIONAL DENTISTRY - AFRICAN EDITION** is a bi-monthly publication:

- February/March
  - June/July
  - October/November
  - April/May
  - August/ September
  - December/January\*
- \* Following year

Submissions of manuscripts, including research and reviews related to clinical practice are invited. Manuscripts are considered for publication with the understanding that they have not been published elsewhere in any form or language and are submitted solely to International Dentistry – African Edition.

### **PEER REVIEW**

#### ***Acknowledgement/copyright***

Submitted manuscripts are acknowledged, and all authors are requested to sign a copyright form on acceptance of the manuscript for publication.

#### ***Review***

All manuscripts are initially reviewed by the Editor and those deemed unsuitable (insufficient originality, serious scientific or methodological flaws, or a message that not within the scope of the journal) are returned to the author(s) within 6 weeks.

Manuscripts are sent, blinded, to two or three experts. After reassessment by the Editor they are returned to the author(s), either for revision or because they are unsuitable for publication.

#### ***Revision***

A request for revision does not imply that the manuscript has been accepted for publication, but is an opportunity to present the best possible article for a decision about publication. Authors are usually given two weeks to return the revised manuscript

#### ***Acceptance/rejection***

The Editor makes the final decision on publication of an article.

### **SUBMITTING ARTICLES**

Manuscripts should be in MS Word format. They should be double--spaced on one side of paper with a wide margin on the left side. Submissions should be sent in digital format to: [dentsa@iafrica.com](mailto:dentsa@iafrica.com) - for attention The Publishing Editor.

International Dentistry - African Edition reserves the right to edit articles for clarity and style as well as to correct English grammar.

### **TITLE PAGE**

- Include full names of all authors, academic degrees and institutional affiliations and locations
- If presented as part of a meeting, please state the name, date and location of the meeting
- Sources of support in the form of grants, equipment, products or drugs must be disclosed
- Full contact details for the corresponding author must be supplied

## **ABSTRACT (OPTIONAL)**

- The abstract (length and format may vary) should follow the title page.
- The abstract should provide the context or background for the study/case and should state its purpose, basic procedures and principal conclusions.
- The abstract should accurately reflect the content of the article.

## **INTRODUCTION**

- A context or background for the study/case should be provided
- The specific purpose/objective should be stated
- Only directly pertinent references should be provided
- Discussion or conclusions from the work being reported should be included

## **TABLES**

- Each table should be presented with double spacing on a separate page
- Ensure that each table is cited in the text
- Number tables consecutively and provide a brief title for each

## **FIGURES**

- Figures should be clearly identified with a number or letter
- Full-face figures of patients where there is no signed consent form must be masked to avoid identification
- Captions with corresponding numbers must be provided on a separate page.
- Each figure must cited in the text
- Digital images only are accepted
- Resolution must be a minimum 300dpi.
- Clinical shots must be at least 90mm wide.
- Preferred formats are .tif or jpeg.
- Digital images can be sent via email accompanying the manuscript or via ftp (eg DropBox/WeTransfer/YouSendIt)

## **NUMBER OF WORDS/REFERENCES**

- The word count (excluding Tables and References) should be a maximum of between 8000-9000
- The number of References should not exceed 50

## **REFERENCES**

All references should appear in the list of references and numbered consecutively as they appear in the text. Only published references can be used. References should include the names and initials of the authors, the full title of the paper, the abbreviated title of the journal, year of publication, volume number and first and last page numbers, eg:

Article reference

Book reference

## **PERMISSIONS**

- Written permission must be obtained for material that has been published in copyrighted material; this includes tables, figures, pictures and quoted text that exceeds 150 words.
- Signed consent forms are required for photographs of identifiable persons. (Signed consent forms by parent/guardian where the patient is a minor)

## **DISCLOSURE OF CONFLICT OF INTEREST**

Authors must disclose any conflict of interest which may arise from any form of commercial association with the content of the manuscript.
